#### ACCIDENT WAIVER AND RELEASE OF LIABILITY

I acknowledge that this athletic event is a test of a person's physical and mental limits and carries with it the potential for death, serious injury and property loss. The risk include, but is not limited to, those caused by terrain, facilities temperature, weather, condition of athletes, equipment, conditions of the roadway, roads, road design, cattle guards, vehicular traffic, actions of others and lack of hydration. These risks are not only inherent to athletics and the sport of bicycling, but are also present for volunteers. I hereby assume all of the risks of participating and/or volunteering in this event. I realize that liability may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained or controlled by them or because of their possible liability without fault.

I certify that I am physically fit, and have sufficiently trained for participation in the event, nor have I been advised otherwise by a qualified medical professional.


#### PARENT GUARDIAN WAIVER FOR MINORS (Under 18 years old)
